



The meeting started at 9.30 am 16th October at principals office. The major decisions of the meeting:





The meeting started at 10. AM on 15th October at Principal's office. The major decisions of the meeting:

The meeting started at 2.p.m on 30th July at principals office. Decisions of the meeting:






- * Regarding public transportation during the pandemic
