## PROFILE

Sacred Heart College, Chalakudy is the realization of a long cherished dream of the people of Chalakudy and the suburbs. The will of the people assisted by the blessings of heaven played a marvelous role in starting the college. The profound fellow feeling of the Clarist Sisters paved the way for the starting of the college in 1980 by the Alvernia Province of Franciscan Clarist Congregation. The college is affiliated to the University of Calicut and is aided by the Government of Kerala. Located within the municipal limits of Chalakudy with a 26-acres serene campus, the college provides a congenial ambience for the overall advancement of the students. In 1991, the college was upgraded to a first grade college by the Government of Kerala. In 2004, the first NAAC visit happened and the college was accredited with B grade. In 2011 the college was re-accredited with A grade and in 2017 the college was re-accredited with A+ grade. In the recent fourth cycle of accreditation by NAAC, the college was re-accredited with A+ grade (CGPA 3.28 out of 4). The college has also been receiving star fund by the Department of Biotechnology since 2018. At present the college offers 9 UG Programmes, 8 PG programmes and 1 integrated PG programme.

## VISION

Committed to serving the nation and humanity, this college, founded in His name, envisages the academic pursuit of truth and the search for righteous living as the supreme task.

## MISSION

The sacred mission of the college enshrines creative scholarship and enrichment of young minds not merely in acquired knowledge, but in the spirit of enquiry, harmonising the spiritual and intellectual



adventures. Fostering an excellent ‘esprit de corps’, we aspire to mould competent persons armed with academic excellence, ethical principles, social sensitivity and spiritual sublimity equipped for innovative leadership enabling their ‘Lux in Tenebris Lucet’.

### **OUR APPROACH**

The college is committed to ensure the development of the total person, which we believe, can be attained through academic excellence, self-discipline and social awareness in a spirit of service to God and man. The college has highly qualified and motivated faculty. Many of our faculty members have higher research degrees like M Phil. and Ph. D. Our faculty members regularly participate in seminars, workshops and other faculty up-gradation programmes to acquaint themselves with the latest developments in their fields. Innovative teaching methods are followed by the faculty to equip the students with the necessary skills to thrive in their chosen field of study.

We are proud that our students have come out with flying colours in the university examinations. They have also bagged ranks in various university examinations. Our track record in extra curricular activities is also impressive.

The college has extensive infrastructure to cater to the academic and non-academic needs of the student community. Well-equipped laboratories, multimedia library, audio visual rooms, seminar halls, auditorium and a spacious playground are evidences to this.

### **POLICIES**

#### **Sacred Heartian Policies**

Policies and procedures at Sacred Heart College are designed to protect the rights and responsibilities of the students and the staff. These policies reflect its vision, mission and values and underpin the teaching, learning interface and signals the institution’s commitment to foster continuous improvement in education. Policies are framed and periodically subject to review, reflection, revision and modification in an attempt to rise to the challenges and pressures higher education institutions face today.

The students have to follow the uniform prescribed by the college from time to time. The management prefers male staff to wear pants and shirt and female staff to wear saree while in college. All are expected to wear modest and formal attire to maintain the decorum of the college.

## **Internal Complaints Committee (ICC) – Policies and procedures**

### **Internal Complaints Committee**

The Internal Complaints Committee was constituted in the college on 7<sup>th</sup> June 2017 in compliance with the instructions as per the UGC (Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and Students in Higher Educational Institutions) regulations. The ICC in association with the NSS unit and the Women's Cell give awareness classes on sexual harassment and abuse, legal measures etc. Staff and students are given freedom to report any such cases. Concerned authorities are notified if any such cases are reported.

Despite the preventive efforts made by the committee, if any incidents of sexual harassment take place, the registration of complaints shall follow the following procedures.

1. Complaints can be lodged directly with any member of the committee. The person to whom the complaint is made should bring to the notice of the committee within 2 working days of receiving it.
2. The complaint may be oral or written. If the complaint is oral it shall be made in written form by the committee or the member who has received the complaint with the signature of the complainant.
3. A complaint should be lodged within six weeks of the incident. In extraordinary circumstances, this could be extended to six months.

4. The committee shall study the complaint and may hear both the complainant and the accused and other involved parties to determine if an enquiry should be made. If so then an enquiry committee will be formed from the committee consisting of not less than 5 persons or not more than 7 persons. 70% of this committee will be from the women community.
5. The process shall be complainant friendly and quick in its decision regarding whether the matter needs to be enquired into or can be taken care of by counselling or mediation.
6. The complainant may withdraw his/her complaint in writing at any time while receiving or during enquiry procedure. In such case, the procedure shall be terminated. If the committee feels or has enough reason to believe that the withdrawal is the consequence or effect of cohesion/intimidation/ threat, exerted by the accused or any person on his/her behalf, the enquiry proceedings shall continue.
7. The enquiry committee shall complete the enquiry in the shortest possible time not exceeding 1 month from the date of registering the complaint.
8. The enquiry committee shall provide reasonable opportunity to the complainant and the accused for presenting/defending their case.
9. The enquiry committee shall then submit a detailed report to the main committee in which it shall communicate its findings based on its investigation.
10. The main committee along with the enquiry committee will then forward its findings and recommendations to the management for further action.

## Anti-Ragging Policy

Ragging is considered to be a criminal offence and is banned in the campus. The Anti-ragging Committee is constituted as per the provisions contained in Clause 6.3(a) of the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions in the year 2009. Anti-ragging cell functions in the campus with clearly defined norms as per UGC Regulations on Anti Ragging, Order of the Hon. Supreme Court on Ragging and UGC circulars on Anti Ragging. The purpose of the cell is to monitor the relationship between fresher and senior students. Orientations are given to the students by the Committee, class tutors and College Union Members. All the students are informed about the following administrative actions which will be taken if anyone is found guilty in ragging cases:

1. Suspension from attending classes and academic privileges.
2. Withholding/withdrawing scholarship/fellowship and other benefits.
3. Debarring from appearing in any test/examination or other evaluation process.
4. Withholding results.
5. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
6. Suspension/expulsion from the hostel.
7. Cancellation of admission.
8. Rustication from the institution for period ranging from one to four semesters.
9. Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.
10. In cases where the persons committing or abetting the act of ragging are not identified, the Institution shall resort to collective punishment.

## **Grievance Redressal Policy**

Strong principles and ethics are inextricably intertwined in the vision of the institution. Student grievances are addressed effectively through an active grievance redressal mechanism. A three-tier grievance mechanism is in place to solve any academic and administrative-related complaints as mandated by the Government. Ragging and sexual harassment is not tolerated by the institution. Institution strictly adheres to norms stipulated by the Government regarding ragging and sexual harassment.

1. All students are bound by the code of conduct of the college.
2. The college recognizes the right of a student to dissent and to fight for the legitimate rights of students.
3. Any form of ragging, sexual harassment and use/possession of narcotics/tobacco/alcohol shall be subject to severe punishment.
4. Abuse on social networking sites will be strongly dealt with.
5. Any offence revealed in CCTV surveillance is punishable.
6. Any student detected in any incriminating situation both within inside and outside the campus shall be reprimanded and counselled.
7. Students found violating the code of conduct shall be given a fair hearing at the departmental level and shall be suspended/dismissed only if deemed necessary.

## **Guidelines for Grievance Redressal Cell**

The Grievance Redressal Cell is a strictly confidential cell functioning as an effective forum for airing the genuine grievances of students in academic, administrative, student services and other related matters. Suggestions dropped in the grievance box are handled by the Principal who heads the Grievance Redressal Committee. This enables in the creation of a more student-sensitive environment, better stakeholder relationships and a congenial teaching-learning atmosphere.

1. Class teachers, subject teachers and Heads are entrusted with the responsibility of dealing with grievances related to academic matters.
2. Staff and student coordinators are assigned the task of solving any complaints related to clubs and associations.
3. Any matter that cannot be resolved within the above framework shall be referred to the Grievance Redressal Committee.
4. Direct complaints can also be made in issues of common interest.
5. The suggestion box can be used for grievances relating to any college-related matters.
6. Issues that require immediate and serious action are attempted to be resolved by the Committee in consultation with the staff, management and parents.
7. Prompt and effective redressal of complaints is ensured through the joint efforts of all the stakeholders.

### **Grievance Redressal Procedure**

A three-level system has been established to deal with all student grievances.

**Class level:** The student mentoring system is utilized to deal with any personal grievances.

**Department level:** Heads of departments and senior faculty resolve any complaints.

**College level:** The Grievance Redressal Committee is responsible to address any issues.

### **Extension Activity Policies**

The college gives prominence to the extension and outreach activities as part of the intention of service and philanthropy towards the society. The college has been practising this for last ten years as a best practice called '**Heart to Heart**'. This practice is followed by all the departments, clubs and cells to orient the extension activities to turn more beneficial for the community and to go in coherence with the policies of the college. The following are the general provisions in the policy.

1. All the extension and outreach activities should involve students of the college. The programme should help in imbibing the spirit of service among the students.
2. The extension activities should help in building the society through the service of the college.
3. Special care and consideration is to be given to the marginalised sections of the society including tribal, economically backward community etc.
4. Aged people should be given special attention when the services are offered.
5. NSS and other cells should follow the guiding principles of '**Heart to Heart**'.
6. Teaching staff should also participate in this programme and contribute in their own way to the community along with their academic exercise.

### **Environment and Energy Policy**

Right from the inception of the college, our policy has evolved towards engaging students in a comprehensive, experiential and educational approach to all aspects of sustainability and reducing our reliance on fossil fuels. All policies are aimed at putting human ecology into action on campus and the local community, and in the process we find ourselves changing not only light bulbs but also our conception of what it means to be '**green**'. Our policies echo our commitment to environmental and social justice that engages students, faculty and staff in the intellectual and practical life of the college.

The college has policies and affirmative action is taken to reduce our carbon footprint. Our long-term strategy is to champion conservation, follow an eco-friendly lifestyle by phasing out single-use plastics, reduce, recycle and compost waste, conserve energy and gradually shift to renewable resources and use non-toxic cleaning products. Green protocol of the State

and Swachch Bharath Abhiyan are observed and promoted with focus on spreading and strengthening awareness.

The college has a policy framework for discarded resource reduction and material management like optimum paper usage, e-waste collection infrastructure, electronics repair and establishing a zero-waste culture on campus by integrating it into activities.

### **Policy Document for the Divyangjan**

The college has enlisted the ensuing welfare and wellness policies and measures for the differently abled students.

1. The college prioritizes accessible and inclusive education with identical facilities for differently abled students seeking admittance. The college puts in incessant efforts so as to make the college barrier free.
2. In affairs related to the acquisition of knowledge and further advancement of it, the library staff are instructed to give proper guidance to the disabled regarding the positionality of books that are arranged in racks with specific intents for easy access to varied bits of info.
3. All the differently abled students avail separate provision for examination assistance seeking the help of a scribe, selected from among the outstanding students of the abled category.
4. Special care is also given to the students with special needs, set in the context of washroom setting and is ensured that the comfort stations are properly cleaned and well-maintained on a regular basis. The abled category of students is made conscious of the plight of the disabled and are also directed to escort the needy to the wash area as and when the situation demands.
5. Ramp facility is made available in the self-financing block of the college that would further aid in the movement of the disabled in the desired direction.



6. The flooring pattern of the college is structured and designed to make it disabled friendly so as to ease the mobility and movement of individuals with disability that would also further enhance the comfort of their stature.
7. Methodical exertions are taken to intensify participation and involvement of differently abled students in Arts and Sports activities.
8. Lift facility is made available in the new block.

### **Policy Document for Financial Support**

Financial Support policies of college, provides financial assistance to the poor and meritorious students in the college to facilitate academic and personal welfare and encourage them to pursue their goals.

1. The college provides merit based and need-based financial assistance.
2. Merit based support goes to students based on their academic achievements and talents like athletics and arts, rather than their financial need.
3. Students may receive scholarships from the college or from outside sources such as non-profit organizations and private businesses.
4. The college has the facility of providing various government and non-government scholarships to the students.
5. When awarding merit-based aid, college examines student's grades in both internal and university examinations and students may need to secure 75% marks in each semester to receive these funds.
6. Need-based financial assistance doesn't consider any factor other than financial background.
7. Eligibility is completely based on the income of the student and her family. A student could be eligible if she is living in a household where the joint annual income is less than 3 lakhs,

she is living in a single parent household, or she is facing notable financial crisis even with an annual income of more than 3 lakhs.

8. A Medical aid scheme is established by the management to provide financial assistance to the students having family income of less than 4 lakh per annum.
9. Financial support is given for staff to attend seminars and conferences, travel and registration.
10. Management has a free education policy for deserving and financially backward students.

### **Policy Document on Feedback Mechanism**

The college has developed a sequence of impressive feedback mechanisms at various levels pertaining to different stakeholders to decipher whether the college functions satisfactorily in various dimensions and also whether its *modus operandi* is in tune with the expectations of the associates concerned. The duly filled up feedback forms collected from all the stakeholders will then be forwarded to IQAC for close analysis. Every month the assorted and verified feedback analyses are systematically forwarded to the Principal for further validation and authentication of responses adhering to strict maintenance of confidentiality of received responses.

1. As teaching-learning processes form one of the pivotal essences in the functioning of an educational institution, to preserve the high quality of the noble domain of teaching that would further accentuate the advancement of learning process, each teacher's feedback is taken from the student community in each semester. All the class teachers concerned will distribute the forms amongst the students and the responses are further consolidated and submitted to IQAC for critical scrutiny. On the foundational basis of these analyses, the Principal designs apt steps to heighten the quality and standard of teaching-learning process in the college.

2. Each faculty member of the college has to submit a monthly performance appraisal report documenting the progress graph of the academic and professional competency acquired hitherto with effect from the date of entry into service. This mode of stratagem serves as an effective feedback process by which both the institution and the faculty member concerned are to assess their levels of performance in varied fields of discipline.
3. The college maintains a Grievance Redressal Cell headed by the Principal and selected senior staff of the college to attend to the immediate needs and queries, deposited in a box by the students of the college, who are free enough to express their opinions and feedbacks on any matters related to their expectations. Due and immediate care is also taken to see whether their grievances are duly addressed on a timely basis.
4. Annually, general body meetings of PTWA are held that function as platforms and floors for active discussions on ways of improvements based on the feedbacks received from the existing occupants of the college.

### **Policy Document for Information Technology**

IT policies of the college is formulated to increase the academic and professional productivity using Information Technology.

1. The computing resources of the college are intended to support the educational, instructional, research, and administrative activities on the campus. It is strived to secure, strengthen and enhance the use of information technology for various legal and ethical purposes.
2. The policy is applicable to all the faculty, students, volunteers, collaborators, and all other stakeholders of the institution.
3. Netiquette, or the code of conduct for healthy online practices, is considered a vital part of the college IT policy and it provides guidelines on acceptable and unacceptable use of IT resources.

4. Institutional IT policy guarantees security and accessibility of system and services to all the members of the community and it safeguards and protects college IT infrastructure and institutional data from other malpractices and misconduct.
5. It does not recommend the use that promotes personal businesses or financial interests of the beneficiaries. Political and religious campaigning or any other external affairs of the individual are strictly prohibited under the policy.

### **Policy Document for Scholarships and Freeships**

Scholarship and Freeship policies of the college is intended to ensure educational equity among students.

1. The students with excellent academic records are provided financial assistance by the institution under the policy of scholarships and freeships. It guarantees various merit, need and category-based scholarships and freeships to the beneficiaries.
2. Government/ University provided and college-sponsored are the two kinds of scholarships provided by the institution to deserving students.
3. Timely distribution of financial aid is assured by the management and PTA.
4. Meritorious and economically backward students benefit from freeships and fee concessions provided by the college management along with other Central and State scholarships.
5. Faculty members and all other stakeholders of the college, sponsor students from poor economic backgrounds to ensure educational inclusivity.

### **Policy Document on e-Governance**

The college with the primary intent of enhancing the system of e-Governance for seamless and perennial access of invaluable data has resolved to put into effect the enriched usage of digital facility in the diverse areas of activities of the college. The obviously discernible areas of accomplishment are as follows:

1. The website of the college gets continuously updated on a routine basis as and when the events take place. It, in essence, is a mirroring of the plethora of activities of the college, made easily accessible and available to the general public, to evaluate the commendable contributions made from the part of the college pertaining to both the academic and extended social responsibility terrains. A host of existing teaching and technical staff of the college undertake the responsibility of website administration and are actively involved in the act of updating the programmes held at the college level. All the significant blocks of information and achievements are posted via social media that include WhatsApp, Facebook, You Tube and Twitter.
2. The process of admission for academic programmes (both UG and PG) has become wholly computerized except in case of seats kept reserved for candidates seeking admission in the management quota.
3. The downward flow of communication from the Principal to the employees is being transacted on an online basis via the official WhatsApp group of the college, though not entirely. In a similar fashion, the communication between the class teachers and the students concerned in matters related to academic pursuits and parental attention is also transferred digitally. Moreover, all the regular updates related to payment of fees and scholarships are also conveyed in the digital format.
4. The college exercises absolute adherence to stuffing of information related to salaried persons via SPARK (Service and Payroll Administrative Repository for Kerala) which is again an electronic means of information transfer.
5. Staff and students of the college and research scholars with prior permission in the written format from the Principal and the UGC Librarian have free access to e-journals and e-resources provided in the college library. The students may avail the facility of INFLIBNET N LIST wherein they could

easily navigate through the vast repository of e- resources that are helpful to them in carrying out minor research activities at the graduate and postgraduate levels. Moreover, the facility of anti-intellectual theft mechanism, Urkund Plagiarism Check facility is also made freely available in the college library to the members of the teaching staff.

## 6. NECTTOS

A complete automation system purchased and implemented by the college in automating routine tasks and reducing manual paperwork. This includes digitizing and centralizing data related to admissions, fee management, attendance tracking, examination management, and other administrative activities. It enables smooth communication, collaboration, and coordination among faculty, staff, students, and parents. By defining clear processes and workflows, it helps in improving efficiency and enhancing overall productivity.

## SC/ST Cell

Scheduled Castes and Scheduled Tribes have been identified as the two most backward groups of Indian Society. They include all such castes, races or tribes, which have been declared as scheduled castes and scheduled tribes by the Constitution of India under the provisions of Article 341 and 342 of the Constitution of India. Scheduled Castes generally represent those communities, which have suffered from the stigma of untouchability in one form or the other. Scheduled Tribes are generally those who have been living in seclusion in hills and forests, more or less untouched by modern civilization and development.

The SC/ST cell of the College was established in 2020 with the purpose to empower the SC/ST students in the College. This unit functions to fulfil the institutional assurance of equality in opportunity through various academic and non-academic activities designed specifically for the upliftment of this community which helps to dissolve the lines of social and economic disparity. The students have been given the chance to approach the cell to clear their queries and get their grievances addressed.

### Objectives of the cell:

- To monitor the implementation of reservation policy of state and central government during admission in the institution.
- To ensure there is no caste based discrimination in the college.
- To inform the SC/ST students regarding various scholarships programs of State Government and UGC.
- To counsel and guide SC/ ST students and help them to manage academic and personal issues of college life effectively.
- To redress the grievances of SC/ST students, if any.
- To enhance the employability of SC/ST students by providing appropriate career guidance.

### Activities

- ◆ Cell gives guidelines to the office staff regarding admission of SC and ST students, if any.
- ◆ Cell discusses about various scholarships that can be given to the students.
- ◆ Informs about the schemes of Government and University.
- ◆ The students are motivated to join skill development programme in the College.
- ◆ Remedial coaching is given by departments in addition to personal counselling.
- ◆ Advanced learners help the weak students to improve their performance.

## **CHOICE BASED CREDIT AND SEMESTER SYSTEM FOR UNDER GRADUATE (UG) CURRICULUM 2019 (CBCSSUG 2019)**

The “Regulations for Choice Based Credit and Semester System for Under Graduate Curriculum 2019” (CBCSSUG 2019) shall apply to all Regular/SDE/Private UG programmes under various Faculties conducted by the University of Calicut for the admissions commencing from 2019, with effect from the academic year 2019-2020. Every programme conducted under the CBCSS in a college shall be monitored by the College Council.

**‘Programme’** means the entire course of study and examinations for the award of a degree. The duration of a UG degree programme shall be six semesters distributed in a period of 3 years. ‘Semester’ means a term consisting of 18 weeks (16 instructional weeks and two weeks for examination). ‘Course’ means a segment of subject matter to be covered in a semester.

**The Undergraduate Programme includes 5 types of Courses: viz; Common Courses (Code A), Core courses (Code B), Complementary courses (Code C), Open Course (Code D) and Audit courses (Code E).**

- a) ‘Common course’ means a course that comes under the category of courses, including compulsory English and additional language courses, the selection of which is compulsory for all students undergoing UG programmes. Every UG student shall undergo 10 common courses (total 38 credits).
- b) ‘Core courses’ are the courses in the major (core) subject of the degree programme chosen by the student. Core courses are offered by the parent department.
- c) ‘Complementary course’ means a course which is generally related to the core course. Complementary courses cover one or two disciplines that are related to the core subject and are distributed in the first four semesters. There shall be two complementary courses in a semester for B.Sc Programmes and only one

complementary course in a semester for B.A Programmes. The complementary courses in first and fourth semester for BA Programme (Type 1) shall be the same. Similarly the complementary courses in second and third semester (Type 2) shall be the same.

- d) ‘Open course’ means a course which can be opted by a student at his/her choice from any other department in the institution during the fifth semester. Total credit allotted for the open course is 3 and the hours allotted is 3. The open course shall be open to all the students in the institution except the students in the parent department.
- e) ‘Ability Enhancement course/Audit courses’: These are courses which are mandatory for a programme but not counted for the calculation of SGPA or CGPA. There shall be one Audit course each in the first four semesters. These courses are not meant for classroom study. The students can attain only pass (Grade P) for these courses. At the end of each semester there shall be an examination conducted by the college from a pool of questions (Question Bank) set by the University. The list of courses in each semester with credits are given below.

**Extra credit Activities:** Extra credits are mandatory for the programme. Extra credits will be awarded to students who participate in activities like NCC, NSS and Swatch Bharath. Those students who could not join in any of the above activities

have to undergo Calicut University Social Service Programme (CUSSP). Extra credits are not counted for SGPA or CGPA.

**Credits:** A student is required to acquire a minimum of 140 credits for the completion of the UG programme, of which 120 credits are to be acquired from class room study and shall only be counted for SGPA and CGPA. Out of the 120 credits, 38 (22 for common (English) courses + 16 for common languages other than English) credits shall be from common courses, 2 credits for project/corresponding paper and 3 credits for the open course. The maximum credit acquired under extra credit shall be 4. If more Extra credit activities are done by a student, that may be mentioned in the Grade card. The credits of audited courses or extra credits are not counted for SGPA or CGPA.

**Attendance:** A student shall be permitted to appear for the semester examination, only if he/she secures not less than 75% attendance in each semester. Attendance shall be maintained by the Department concerned. Condonation of shortage of attendance to a maximum of 10% in the case of single condonation and 20% in the case of double condonation in a semester shall be granted by University remitting the required fee. Benefits of attendance may be granted to students who attend the approved activities of the college/university with the prior concurrence of the Head of the institution. Participation in such activities may be treated as presence in lieu of their absence on production of participation/attendance certificate (within two weeks) in curricular/extracurricular activities (maximum 9 days in a semester). Students can avail condonation of attendance for maximum four semesters during the entire programme. (Either four single condonations or one double condonation and two single condonations during the entire programme) .If a student fails to get 65% attendance, he/she can move to the next semester only if he/she acquires 50% attendance. In that case, a provisional registration is needed. Such students can appear for supplementary examination for such semesters after the completion of the programme. Less than 50% attendance requires Readmission. Readmission is permitted only once during the entire programme.

**Grace Marks:** Grace marks may be awarded to a student for meritorious achievements in co-curricular activities (in Sports/Arts/NSS/NCC/Student Entrepreneurship) carried out besides the regular hours. Such a benefit is applicable and limited to a maximum of 8 courses in an academic year spreading over two semesters. In addition, a maximum of 6 marks per semester can be awarded to the students of UG Programmes, for participating in the College Fitness Education Programme (COFE). Grace marks are given to students who are members of CUSSP. A total of 12 marks is distributed in four semesters, wherein the student will receive 3 marks as grace marks per semester.

## REGISTRATION

1. A student shall be normally permitted to register for the examination if he/she has required minimum attendance. If the student has a shortage of attendance below 65% in a semester, the student shall be permitted to move to the next semester ( if the attendance is more than 50% - Provisional registration) and can write the examination for the entire courses of the semester in which shortage of attendance occurs as supplementary examination only after the, completion of the entire programme. In such cases, a request from the student may be forwarded through the Principal of the college to the Controller of Examinations within two weeks of the commencement of the semester. If the attendance is less than 50%, the student is ineligible to continue the programme and has to seek readmission. There will not be any Repeat semester in CBCSSUG 2019.

2. A student who registered for the course shall successfully complete the programme within 6 years from the year of first registration. If not, such a candidate has to cancel the existing registration and join afresh as a new candidate.

## EVALUATION AND GRADING

Mark system is followed instead of direct grading for each question. For each course in the semester letter grade and grade point are introduced in a 10-point indirect grading system.

An aggregate of P grade (after external and internal put together) is required in each course for a pass and also for awarding a degree (A minimum of 20% marks in external evaluation is needed for a pass in a course. But no separate pass minimum is needed for internal evaluation). No separate grade/mark for internal and external will be displayed in the grade card; only an aggregate grade will be displayed. Also the aggregate marks of internal and external are not displayed in the grade card. A student who fails to secure a minimum grade for a pass in a course is permitted to write the examination along with the next batch. After the successful completion of a semester, Semester Grade Point Average (SGPA) of a student in that semester is calculated using the formula

$$\text{SGPA} = \frac{\text{Sum of the credit points all courses in a semester}}{\text{Total credits in that semester}}$$

The Cumulative Grade Point Average (CGPA) of the student is calculated at the end of a programme. The CGPA of a student determines the overall academic level of the student in a programme and is the criterion for ranking the students. CGPA can be calculated by the following formula.

$$\text{CGPA} = \frac{\text{Total credit points obtained in six semester}}{\text{Total credits acquired (120)}}$$

### Course Evaluation

The evaluation scheme for each course shall contain two parts

1) Internal assessment 2) External Evaluation

20% weight shall be given to the internal assessment. The remaining 80% weight shall be for the external evaluation.

**1) Internal Assessment :** Components with percentage of marks of Internal Evaluation of Theory Courses are- Test paper 40%, Assignment 20%, Seminar 20% and Classroom participation based on attendance 20%.

For practical courses - Record 60% and lab involvement 40% as far as internal is concerned.

For the test paper marks, at least one test paper should be conducted. If more test papers are conducted, the mark of the best one should be taken.

To ensure transparency of the evaluation process, the internal assessment marks awarded to the students in each course in a semester shall be notified on the notice board at least one week before the commencement of external examination. There shall not be any chance for improvement for internal marks. The course teacher(s) shall maintain the academic record of each student registered for the course, which shall be forwarded to the University by the college Principal after obtaining the signature of both course teacher and Head of the Department.



## 2) External Evaluation

External evaluation carries 80% of marks. All question papers shall be set by the University. The external question papers may be of uniform pattern with 80/60 marks. The courses with 2/3 credits will have an external examination of 2 hours duration with 60 marks and courses with 4/5 credits will have an external examination of 2.5 hours duration with 80 marks. The external examination in theory courses is to be conducted by the University with question papers set by external experts. The external examination in practical courses shall be conducted by two examiners – one internal and an external, the latter appointed by the University. The project evaluation with viva can be conducted either internal or external which may be decided by the Board of Studies concerned.

## RULES FOR ADMISSION

1. Admission of students for the UG and PG Programmes will be under Choice Based Credit Semester System.
2. At the time of interview the applicant should produce the following certificates in original.
  - (i) Transfer Certificate from the school/college last attended.
  - (ii) Course and Conduct Certificate.
  - (iii) Mark List and Pass Certificate (P.G. students have to submit the degree/diploma in original at least by September of the same year).
3. Immediately after the interview, the candidate if selected will be enrolled on payment of the 1<sup>st</sup> instalment of fees and the submission of the certificates.

## COLLECTION OF FEE

### **Fees are collected as per the Governmental rules.**

- a. The Tuition fees including the special fees prescribed will be collected on the date of admission.
- b. If any student fails to pay the fees or special fees on the due date, she shall be liable to pay a fine of Rs. 5/- along with the fees on or before the 10<sup>th</sup> day, after the due date. If the 7<sup>th</sup> day, happens to be a holiday, the next working day will be counted as the 7<sup>th</sup> day.
- c. If the fee with the fine is not paid on or before the 7<sup>th</sup> day after the due date, an additional fine of Rs. 10/- will have to be paid. If the fee and fines are not paid within 15 days from that date, the name of the student will have to be removed from the rolls of the college. If she is to be re-admitted, she has to apply for the special permission of the Principal and also has to remit a re-admission fee of Rs. 100/- in addition to the arrears with fine.
- d. If the fee and fines are not paid on the 11<sup>th</sup> day or within 15 days, from that date, the name of the student will be entered in a special

register of defaulters. The attendance of the student would be taken every day as usual and her attendance or absence would be marked. If the student settles the arrears of fees with fines before last opportunity given for such a settlement, she would be granted attendance as per actual presence or absence as record. If the student does not pay the dues till the last date prescribed, she would not be allowed to appear for the examination.

- e. Those who are from the regular and self financing courses should remit full course fee before collecting transfer certificate.
- f. For self financing courses, the fee will be fixed as per the norms of the University of Calicut and the Govt. of Kerala.

### **INSTITUTIONAL CODE OF ETHICS**

1. The institution adheres to a conduct of duties in a righteous manner and in accordance with the principles of honesty, trust, transparency and fairness.
2. The institution should balance the diversity and difference through a culture of tolerance, discussion and forgiveness among stakeholders.
3. The institution should adopt standards, policies and procedures to promote and ensure equal opportunity without any discrimination.
4. Dedication to the vision and mission of the institution while cultivating one's knowledge, skill and attitudes to achieve excellence within the regulatory boundaries.
5. The institution must foster a shared vision and ensure a secure, safe environment where all stakeholders feel included and accepted.

6. The institution should ensure optimal resource utilisation – economic, environmental and social – to achieve a sustainable future.

### **GENERAL RULES AND CODE OF CONDUCT FOR STUDENTS**

1. The students' registration in the college is considered an expression of willingness to abide by all the rules and regulations prevailing in the college. Every student therefore is committed to the observance of these rules.
2. Life in the College must be inspired by unity, mutual trust and co-operation among the management, staff and students. Every student must make it a part of her personal duty to attend classes daily and punctually. Students are expected to be in class at the first bell and begin the day by reciting the common prayer. When teachers are on leave, students shall remain in the class and do the work assigned to them for the period. They should not loiter along the verandas or crowd at the gate or in the campus road. No student is allowed to enter classes of other batches when the class is in session.
3. Attendance shall be marked at the beginning of each class, whether lecture, practical, or tutorial, by the teacher-in-charge of the class. Students should occupy their respective seats before attendance is taken. They should not leave the classroom, nor should late comers enter the classroom without the permission of the teacher-in-charge of the class. Students availing leave for more than ten working days without submitting proper leave applications will have their names removed from the rolls. They may be readmitted only at the discretion of the Principal.
4. Students are not expected to leave the campus during the working hours. In case of an emergency, sanction must be obtained from the Principal with a written request duly countersigned by the Parent/Guardian/Warden and the class teacher.

5. Important notices are posted on the respective notice boards. It is the responsibility of the students to read these notices and to respond immediately if summoned.
6. Learning not to damage property whether public or private is one of the primary requirements for civilized behaviour. It is the responsibility of the student to treat college property with care and to keep the buildings and the campus neat and clean. Students shall not disfigure, damage or destroy public or college properties. In the event of such damage or destruction the cost of such properties will be recovered from the student or students concerned. Disciplinary action will also be taken against the delinquents.
7. Students should not throw litter in the campus, rather place them only in the waste bins. Students are bound to keep the campus neat and clean.
8. Students are requested to see that an attitude of respect, love and consideration is reflected in their behavior towards elders, teachers, peers and others.
9. All students should read and understand library regulations. Students are advised to make use of the library during free periods. Those who prefer to sit in the classroom for doing academic work should not any way cause disturbance to the neighbouring class. Students who are not attending classes or lectures or working in the Library, during college working hours shall take special care not to disturb classes that are going on.
10. The students have to wear the uniform prescribed by the college from to time. Students are advised to dress modestly. Tights, leggings, miniskirts, transparent clothes, short-tops, sleeveless and deep necklines are not allowed.
11. Students should not wear gold ornaments except a pair of earrings.
12. Unauthorized use of mobile phones is not allowed in the campus for students.
13. Every student is expected to wear her identity card with photograph attested by the Principal while on campus and when

travelling to and fro from the College. Failure to do so will invite strict disciplinary action. Students should produce their identity cards for inspection whenever they are required to do so by the members of the Staff or the College authorities. The identity cards must also be presented at the time of payment of each installment of fees, while taking the hall tickets, mark lists and other certificates and also in the library. ID card should be surrendered after the completion of the programme or if the student discontinues.

14. The primary purpose of Examinations and Test papers is to evaluate the academic progress of the students and also to give them training. Exemption from attendance at assessments and test papers is granted only by the Principal. Malpractices during assessments and examinations will be dealt in accordance with the gravity of the incident. The principal has the right to rusticate/ban/ suspend students practicing unethical academic behavior or supporting such behavior in the campus.
15. Plagiarism or other forms of academic dishonesty, furnishing false information to any college official, faculty or office, forgery, alteration or misuse of any college document, record, or instrument of identification, copying in examination etc. will call for strict disciplinary action amounting to suspension and dismissal.
16. Silence shall be maintained in the college library and in the office premises.
17. Ragging is prohibited by law in the college campus.
18. Political activism is strictly banned in the campus, as it is detrimental to the teaching learning process. (Vide: W.A. No. 535 of 2003- Judgement dt. 26/5/2003 of the Honourable High Court of Kerala). Nevertheless, the college recognizes the right of a student to dissent and to fight for the legitimate rights of students. However, these rights should not fringe upon the rights of other students to attend class and/or of the teacher to conduct his/her lessons. Students shall not take out demonstrations along

the corridors or enter the classrooms and obstruct the teaching process.

19. Students are strictly prohibited from organizing, attending or participating in any activity or agitation sponsored by the politically based student organizations.
20. The college being a temple of learning and an exclusive academic zone, nobody shall involve in any form of strike or agitation including slogan shouting, dharna, gherao, burning effigy or indulge in anything which may harm the peaceful and serene atmosphere of the institution and shall eschew from violence within the campus and the hostel.
21. Any case of criminal activity or violation of law and order in the college campus will be reported to the police and the police shall register a case and initiate action against the offenders.
22. Students who are charged with a criminal offence or are under suspension will not be allowed to enter the college campus without the permission of the Principal.
23. Unauthorized entry of outsiders into the campus as well as to the hostel is strictly prohibited. Without specific permission of the authorities, students shall not bring outsiders to the college or to the hostel.
24. Student shall seek prior permission from Principal:
  - To conduct meetings in the College buildings or anywhere in the College premises.
  - To use Megaphone, loudspeakers etc. and posters, banners or boards to be put up on the campus.
  - To publish matters in Newspapers, Magazines, Journals or Social media in the name of the College.
  - To collect money from others within the campus or the hostel.
25. There is a Students' Grievance Redressal Cell in the college. In case the students have any grievance or complaint they may approach the Head of the Department first and if not satisfied, the Principal. The Principal will, at her discretion refer the

matter to the Students' Grievance Redressal Cell consisting of the Vice- Principal (or an impartial senior teacher), one HoD and one senior teacher (Selection Grade/Reader/Associate Professor) nominated by the Principal.

26. The Principal has the power to declare holiday for the college if she finds the peaceful academic functioning of the college is getting seriously affected.
27. Students are not permitted to drive their vehicles into the prohibited area of the campus.
28. In order to ensure a congenial academic atmosphere in the campus, the election process shall be in the parliamentary form. The college parliament will be constituted with the representatives elected from each class and the college parliament will in turn elect the college level and university level office bearers.
29. In support of the college's commitment to the health of the campus community, Sacred Heart College is a smoke and tobacco free college. Smoking, consumption of alcohol, tobacco, drugs or any tobacco derived or containing products is strictly prohibited in the premises of college. Smoking and tobacco use is prohibited in personal vehicles parked on college property. Those who violate the policy are subject to disciplinary actions.
30. The Code of Discipline exists primarily to provide the discipline necessary for an academic environment. In the matter of internal discipline and enforcement of the rules and regulations, the decision of the Principal shall be final. The management has the right to suspend /dismiss any student for breach of discipline.

## **LIBRARY RULES & REGULATIONS**

1. Only the members of the staff & students of this college are entitled to the use of library.



2. The library is kept open from 8.00 a.m. to 5.00 p.m. on all working days. Books can be issued and returned from 8.00 am to 3.30 pm.
3. Students are allowed to take only paper and pen in the library. Other books, umbrellas etc. should be left at the entrance.
4. Strict silence must be observed in the library and its immediate premises, especially in the library veranda.
5. A student in degree class is allowed to borrow three books and PG students 10 books at a time and borrower's tickets will be issued accordingly, which are not transferable. One book can be borrowed against each ticket. When the book is returned to the library, the tickets will be given back.
6. Students are expected to take care of the tickets and slips issued to them. If a ticket or slip is lost, a duplicate will be issued on payment of fine as fixed by the librarian.
7. Students shall return their tickets at the close of the course of study. Those who discontinue the course should return their tickets before applying for T.C. Fine would be levied for the misuse of library tickets.
8. Members are not permitted to sub lend the books or ticket issued to them.
9. Students are permitted to walk amidst the bookshelves and to take any book to the reading table. After reading, they shall leave the books on the reading table so that books may not be misplaced. A book misplaced is virtually a book lost.
10. Books should be handled with great care. Pencil marks and ink stains made in books, destruction of binding, tearing of pages or pictures etc. will invite fine. Before leaving the counter, students must examine the books borrowed and report to the library staff any damage found therein. If they fail to do so, they will be held responsible for any damage detected afterwards.
11. Subject books and fiction are issued for 14 days. An overdue charge of Rs.1/- for subject books and fiction shall be levied after two week.

12. Damage to or loss of books on loan should be immediately reported to the librarian. Members may replace such books or pay the amount as fixed by the librarian. Books will not be issued to such members till the loss has been compensated.
13. The librarian can recall from the borrower any book at any time.
14. Once a book is issued, it will not be taken back on the same day. Renewals are not permitted.
15. Readers must be considerate to others. Kindly leave the magazines, journals or papers, back in their respective places thus making it convenient to other readers. Damage to these will be treated seriously.
16. Dictionaries, encyclopaedias, current periodicals and other reference books shall not be lent out.
17. Students are expected to return all library books before they leave for their revision holidays.
18. The staff members are not allowed to lend the library books to those outside the college.
19. At the end of the academic year, all the members of the staff are expected to return all the books and periodicals borrowed at least three days before the closing date.
20. Internet access to students are meant only for study purpose. They are free to use internet for Assignment and Project Work. One hour for PG students and 30 minutes for UG students per day.
21. The library has an active readers' forum. Students who are interested can be its members.

### **PROFESSIONAL ETHICS FOR FACULTY**

1. Faculty members should adhere to a responsible pattern of conduct and demeanour.
2. Faculty should respect the right/dignity of the student in expressing her opinion.
3. Faculty must recognise the differences in aptitudes and capabilities of students and strive to meet their individual needs.

4. Faculty should encourage students to improve their attainments, develop their personalities and simultaneously contribute to community welfare.
5. Faculty should behave in an affectionate manner to the students and refrain from any sort of vindictive behaviour.
6. Faculty should be available and approachable to students even outside class hours.
7. Faculty should seek to make professional growth continuously through study and research.
8. Faculty should perform their duties in the form of teaching, tutorial, practical and seminar work conscientiously and with dedication.

### ASSOCIATIONS, CLUBS & FORUMS

Sacred Heart College acknowledges that development and growth of an individual does not take place in the classroom alone. Development of talent and skills is essential for the integral formation of the personality of a student. With this insight, the college has a number of associations, clubs and forums. A student can join any number of these according to her taste/talents. There will be a faculty coordinator for each body who will be in charge of its overall supervision.

## STATUTORY ASSOCIATIONS

### 1. The College Union

Student participation in the activities of the college is enhanced by the formation of the College students union comprising of elected representatives of the Students. College Union is a body selected every year by the students through an election process and its tenure is one year. The election of the office bearers of the union is conducted on Democratic norms observing University rules. There is a College Union Advisor who is a senior member of the faculty. The union involves in conducting various extra curricular and co-curricular activities. They discuss various matters with the union, staff advisor and principal. Election to the College Union is conducted every year when affiliating University issues orders in this regard. At present the College follows the Parliamentary system of election as per the provision of the orders of Honourable Supreme Court of India, Honourable High Court of Kerala, J M Lyngdoh Committee recommendations and the schedule issued by the affiliating universities of Kerala.

### 2. Subject Associations

In subjects where the instructions are offered as main, the college has subject associations. Each subject association has an elected Secretary and will function as per the guidelines issued by the head of the department. The broad objective of the associations is to give students exposure to the subject beyond textbooks by organizing lectures, debates, quizzes etc.

### 3. National Service Scheme (NSS)

The college has two units of NSS, unit No. 76 nd 84. It aims at education through community service. It is intended to arouse the social conscience of the student by preparing them to be useful to society.

Motto of NSS : Healthy Youth for Healthy India The specific objects are to provide them

- a. To work with and among the people.
- b. To engage in non-violent constructive social action.
- c. To enhance their knowledge of themselves and the community through a confrontation with reality.

- d. To put their scholarship to practical use in mitigating at least some of the social problems.
- e. To practice democratic leadership.

**Membership** in NSS is voluntary and is strictly on selective basis. Each student is subject to its discipline and code of behaviour. Every student attending NSS will be required to put the minimum of time equivalent to 120 hours each academic year including the hours of work put in during the camp days. Those who complete 240 hours of work in 2 years and attend the 7-day camp are eligible for a certificate issued by the University.

**Application** for enrolment will be called for by the programme officer of the unit at the beginning of each academic year.

Membership in NSS and a certificate to that effect from the University will be treated as additional qualification while making recruitments to public services.

#### **4. Parent Teacher Well-Wishers Association**

This association is established to create an atmosphere of friendship, co-operation and unity among the guardians of students, faculty members and well wishers of the college in matters pertaining to functioning of the college and to foster feeling of unity in all spheres of development of the college.

#### **5. Alumnae Association**

The college has an Alumnae Association to continue the Sacred Heart Fraternity after completing education from the college. The association also aims at tapping the potential of its alumni for the enhancement of the institution.

The annual meeting of the Alumnae Association will be conducted every year during the time of Deepavali. Alumnae association is registered under the Travancore-Cochin Cultural Scientific and Charitable Societies Registration Act (Act 12 of 1955) with registration number TSR/TC/301/2022
