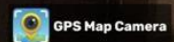

Solid and E-Waste Collection Service Agreement

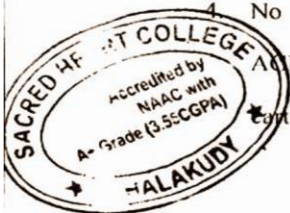
This Solid Waste and e-waste Collection Services Agreement, dated as of 08/08/2020, is entered into by and between Haritha Karma Sena of Chalakudy Municipality and Sacred Heart College, Chalakudy.

Purpose of the Agreement

The purpose of this AGREEMENT is to establish the terms for the collection and disposal of solid waste generated by non-manufacturing activities of Sacred Heart College, Chalakudy by Haritha Karma Sena of Chalakudy Municipality and to establish a frame-work for mutual cooperation in the management of solid waste disposal.

Conditions

1. Acceptable waste: All types of non-hazardous solid wastes.
2. Fees for collection and disposal services will be as set by the Chalakudy Municipality.
This fee will be the same as fees charged to commercial customers of the Chalakudy Municipality.
3. The solid and e-wastes generated in the College will be collected as per the requirement of the College and a systematic administration of activities for the collection and disposal of solid and e-waste materials will be implemented.
4. No party shall be liable for any failure to perform its obligations under this AGREEMENT where such failure is as a result of natural calamity such as flood, earthquake, etc.

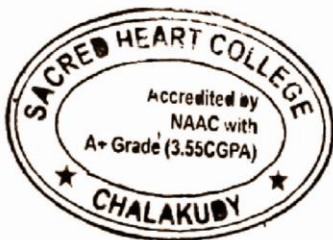


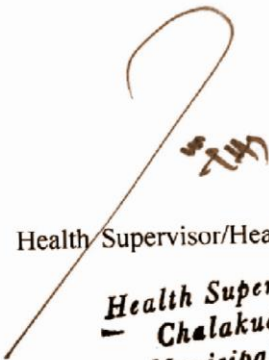
